How do we ensure prevention of chronic diseases in the future with limited economic resources and healthcare professionals?

The healthcare systems internationally are under pressure due to the increasing prevalence of chronic diseases. Especially multiple chronic diseases are rising across the world creating greater inequality in access to healthcare. Inequality in healthcare often leads to more chronic diseases and increases the complexity of multimorbidity which have significant consequences for both the patient, relatives, and the healthcare system.

As most healthcare systems are looking into limited economic resources and healthcare professionals, prevention is the key factor to avoid the rising burden of chronic diseases.

However, the earlier a chronic disease can be diagnosed, the lower is the need for treatment, medicine or surgery. Early detection is addressed with new screening initiatives, integrated care and continuity of care (clinical pathway) initiatives.

Questions guiding the panel debate:

- 1. How do we secure quality of life for patients with chronic disease, and access to the right treatment?
- 2. With limited healthcare professionals how do we make chronic patients more responsible for their own treatment? Is the use of home monitoring and digital solutions the answer?
- 3. How do we change the healthcare systems from the perspective of treatment to having greater focus on prevention and early detection?
